## **AROUND SCHOOL:**



Visit to the Qingpu traffic police dept. in April.

**Goal:** to place bumpers (high concrete or low yellow) along Gaoguang Rd., to help decreasing speed.

**Outcome:** these bumpers cannot be placed on such a road, according the Chinese regulation.

What is **possible** is to have « Warning: school » signs placed on the both sides of the school, in order to attract attention on safety.

### **OTHER PROJECTS:**



In March/April: organization by LFS of an international swimming competition, involving 12 schools (over 300 pupils) plus LFS and DSS

**Constraint:** guests were living in families, which brought a heavy pressure on the bus network

**Work done:** a temporary network with additional lines was created in less than 2 weeks, without disturbing the existing one

**Result:** some delays, but overall, no security problem and a good level of satisfaction
